## **Action Required:**

Approval of the Splash Pad Project bid package provided by Cameron McCarthy.

## Motion for Business Item / Proposed Motion for Consent Agenda:

Motion to approve the Splash Pad Project Notice of Award to Green Construction as the lowest responsible bidder in the amount not to exceed \$161,586.23.

#### Background of Issue:

Attached you will find the Splash Pad Project Recommendation from Cameron McCarthy and the bid tabulations from the May 31st, 2024, bid opening.

The bids request documents included a sales tax of 8.5% which is incorrect for the City of White Salmon. Since all bidders included the 8.5% the lowest bidder still stands. This modified the quoted bid price of \$163,087.96 (8.5%) to \$161,586.23n(7.5%).

The bids were reviewed by Cameron McCarthy and city staff. Green Construction was determined the lowest responsible bidder.

#### **Council Options:**

City Council has the following options available at this time:

- 1. Accept the Staff Recommendation.
- Revise the Staff Recommendation.
- 3. Other action as desired by council.

#### **Fiscal Analysis:**

Approval of this bid award will require a budget amendment to the Municipal Capital Improvement Fund to change the allocation of \$161,586.23 to the Splash pad line item from the Park Replacement Project line item. The funding was moved to the Park replacement equipment line item when the city discovered the issues with a diesel tank in the location of the splash pad. This issue has since been handled and the splash pad is cleared to move forward with no further delays.

# **DEI & Stakeholder Analysis:**

Improvements to the City's recreational opportunities are enjoyable for all White Salmon visitors and residents.

#### **Policy & Plan Implications:**

This project was listed in the Parks Master Plan as well as the Capital Facilities Improvement plan.

#### Recommendation of Staff/Committee:

Staff Recommends approval the Splash Pad Project notice of award to Green Construction as the lowest responsible bidder in the amount not to exceed \$161,586.23.

The conditions of this Bond are such that if the Owner accepts the bid of the Contractor within the time specified in the bid documents, or within such time period as may be agreed to by the Owner and Contractor, and the Contractor either (1) enters into a contract with the Owner in accordance with the terms of such bid, and gives such bond or bonds as may be specified in the bidding or Contract Documents, with a surety admitted in the jurisdiction of the Project and otherwise acceptable to the Owner, for the faithful performance of such Contract and for the prompt payment of labor and material furnished in the prosecution thereof; or (2) pays to the Owner the difference, not to exceed the amount of this Bond, between the amount specified in said bid and such larger amount for which the Owner may in good faith contract with another party to perform the work covered by said bid, then this obligation shall be null and void, otherwise to remain in full force and effect. The Surety hereby waives any notice of an agreement between the Owner and Contractor to extend the time in which the Owner may accept the bid. Waiver of notice by the Surety shall not apply to any extension exceeding sixty (60) days in the aggregate beyond the time for acceptance of bids specified in the bid documents, and the Owner and Contractor shall obtain the Surety's consent for an extension beyond sixty (60) days.

If this Bond is issued in connection with a subcontractor's bid to a Contractor, the term Contractor in this Bond shall be deemed to be Subcontractor and the term Owner shall be deemed to be Contractor.
