Proposed update to the City's Tree Protection Ordinance (TPO) will be open for public comment starting July 10th through August 9th. Local adoption is anticipated in October of 2024.

The City is updating its Tree Ordinance to keep it current with International Society of Arboriculture (ISA) standards, as well as improve administration of tree protection and removal. Proposed measures to avoid or reduce such increases are:

Not applicable—such increases not anticipated.

2. How would the proposal be likely to affect plants, animals, fish, or marine life?

The proposed amendments associated with the City's TPO update are not anticipated to appreciably affect fish, or aquatic life, as critical areas ordinance protections persist independent of this update. Further, one of the goals of the TPO update is to achieve greater protection for large, mature trees. and provide greater protection for understory plants located within tree protection areas. The TPO will provide additional incentives to retain groves of three significant or special trees or more. This will, in turn, provide additional urban habitat for animals.

Proposed measures to protect or conserve plants, animals, fish, or marine life are:

Beyond what is stated above, the proposed update does not include additional measures to protect or conserver plants, animals, fish, or aquatic life. Development projects proposed must comply with the White Salmon Municipal Code and all other applicable local, state, and federal regulations.

3. How would the proposal be likely to deplete energy or natural resources?

The proposed amendments associated with the City's TPO update are not anticipated to deplete energy or natural resources. The proposed amendments are intended to keep the HTO current with the International Society of Aboriculture (ISA) stamdards and provide for better administration of the code. Development projects proposed must comply with the White Salmon Municipal Code and all other applicable local, state, and federal regulations.

Proposed measures to protect or conserve energy and natural resources are:

The proposed amendments to the TPO do not include additional measures to protect or conserve energy and natural resources.

4. How would the proposal be likely to use or affect environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection, such as parks, wilderness, wild and scenic rivers, threatened or endangered species habitat, historic or cultural sites, wetlands, floodplains, or prime farmlands?

The proposed amendments associated with the City's TPO update are not anticipated to affect other environmentally sensitive areas or areas designated (or eligible or under study) for governmental protection. Development projects proposed within the City's critical areas and/or their buffers must comply with the White Salmon Municipal Code and all other applicable local, state, and federal regulations.

Proposed measures to protect such resources or to avoid or reduce impacts are:

The proposed amendments are intended to retain canopy, consistent with the City's adopted 2019 Community Forestry Management Plan.

5. How would the proposal be likely to affect land and shoreline use, including whether it would allow or encourage land or shoreline uses incompatible with existing plans?

The TPO update is not anticipated to affect land uses and will not act as regulations within shoreline jurisdiction. Development projects proposed within the City shoreline jurisdiction must comply with the White Salmon Adopted Shoreline Master Program and all other applicable local, state, and federal regulations.

• Proposed measures to avoid or reduce shoreline and land use impacts are:

The proposed amendments to the TPO do not include additional measures to avoid or reduce shoreline and land use impacts.

6. How would the proposal be likely to increase demands on transportation or public services and utilities?

The proposed amendments associated with the City's TPO update are not anticipated to increase demands on public services and utilities. Proposed amendments are intended to retain mature trees and to provide incentives for retention from a stormwater flow control perspective. current with best available science and better administration of the code. Retaining mature trees to assist with stormwater treatment will assist in mitigating impacts caused by stormwater runoff on transportation, public services and utilities.

Proposed measures to reduce or respond to such demand(s) are:

Not applicable—increased demands on transportation or public services and utilities not anticipated with this code update.

7. Identify, if possible, whether the proposal may conflict with local, state, or federal laws or requirements for the protection of the environment.

The proposed amendments are not anticipated to conflict with local, state, or federal laws or requirements for the protection of the environment. The purpose of this update is to respond to the community's desire to protect and preserve mature trees, while also balancing the needs of development through thoughtful tree removal and replanting strategies.
