Enclosed is a Determination of Non-significance (DNS) for the DRAFT Tree Ordinance Update. The City proposes updating to the City's Tree Protection Ordinance (TPO) will be open for public comment starting July 10th through July 24th. Local adoption is anticipated in October of 2024. A copy of the draft plan documents may be requested at City Hall.

This DNS is issued under WAC 197-11-340(2), and the comment period will end on August 9, 2024. Comments can be submitted by mail to City of White Salmon (PO Box 2139, White Salmon WA 98672), in person at City Hall's Dropbox (100 N. Main), or by email correspondence at Erikac@whitesalmonwa.gov. Per the White Salmon Municipal Code 18.20.170 - Environmental Protection (SEPA review) Appeal, any agency or person may appeal this DNS to the city council. The proponent or any aggrieved party may perfect such appeal by giving notice to the responsible official within ten days of the decision being appealed. Appeals shall not be deemed complete without payment of the appeal fees applicable, payable to the City of White Salmon. Appeals must be filed by July 24, 2024.

A public hearing regarding the City's Tree Protection Ordinance (TPO), with a virtual/telephonic attendance option, will be held during the Planning Commission meeting on Wednesday, August 28, 2024, at 5:30 PM. The hearing will be in the City Council Chambers (119 NE Church). Those interested may attend the meeting and provide oral comments at the August 28 meeting. SEPA DETERMINATION OF NONSIGNIFICANCE (DNS)

Environmental Checklist No: WS-SEPA-2024.002

Description of Proposal: The DRAFT Tree Ordinance Update. The City is updating its Tree Protection Ordinance (TPO) to keep it current with International Society of Arboriculture (ISA) standards, as well as improve administration of tree protection and removal. Development projects located near a significant or special tree would be reviewed for compliance with the TPO. In the future, the City may continue to implement the policy goals and objectives outlined in the City's Comprehensive Plan, Community Forest Management Plan and support efforts towards greater climate and wildfire resiliency. This is a non-project proposal. The TPO was developed to be compatible with existing City development standards. Development projects proposed within the City's limits must conform with the White Salmon Municipal Code, and all other applicable local, state, and federal regulations.

The proposed Tree Protection Ordinance is currently under review and local adoption is anticipated in October 2024. The application was determined to be completed on July 3, 2024.
